# Case studies

### Ashfield Healthcare (part of Inizio)

#### Overview

Ashfield (now part of Inizio Group) provides multiple services – from staff outsourcing to commercial communications and even professional healthcare education. While many of its services are VAT-exempt across many of its operating jurisdictions, the sheer volume of domestic and global transactions as well as range of specific circumstances surrounding each mean its tax determination and calculation system must be capable of rising to meet the most complex of tax scenarios.

#### The challenges

After implementing Oracle Cloud ERP, Ashfield identified a series of apparent shortcomings related to the platform's tax capabilities. Requiring a specialist with experience of managing projects covering multiple regimes around the globe, it instructed Innovate Tax to complete a full VAT system review of its Oracle Cloud ERP indirect tax configuration and setup.

The Innovate Tax team, led by Global Solutions Architect, Andrew Bohnet, found the Oracle setup was running incorrectly and was at risk of generating inaccuracies within Ashfield's tax data.



#### The results

## Specialized Bicycles

#### Overview

Specialized has been a long-term investor in Oracle software products. It originally started by using the Oracle 11i ERP, but in 2017 decided to upgrade to the new version, R12. Specialized engaged the services of a Systems Integrator to upgrade to R12. However, soon after go-live, Specialized identified a gap in its ERP: a lack of tax-specific functionality.

#### The challenges

Specialized's bikes start out as component parts in the Far East, where much of its manufacturing also takes place. They are later shipped through countries in Asia en route to Europe. Specialized, which is based in the Netherlands, would subsequently move its products on to retailers in all major markets around the world, creating a truly global supply chain.

It meant Specialized was liable to pay and recover taxes in numerous countries – a process that simply could not be completed efficiently and accurately without an industry-leading automated solution.

We implemented our industry-leading automated tax determination solution with country-specific tax logic for every nation in which Specialized had tax registrations. This was supported by our RapidInstall toolkit and global tax content. We delivered:
